To be able to use the charging stations of the various companies, you usually have to either create an account or download an app. A suitable cable is provided in the car. Payment is then made directly by credit card. Border crossings and ferry trips with electric cars are not permitted. The minimum age for luxury e-cars (vehicle categories: NCE; JCE; NCF; LSE) is 30 years.
